The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation shall be:

**GARY A. BELAGA, MD, P.A.**

The address of the principal office of this corporation shall be 756 Riverside Drive, Coral Springs, FL 33071, and the mailing address of the corporation shall be the same.

**ARTICLE II**

This corporation may engage or transact in any and all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation. This corporation is also organized to practice medicine, and to take all actions that are necessary or proper in connection with that practice.

**ARTICLE III**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time shall be 1000 shares of common stock at a par value of \$1.00 per share.

#### **ARTICLE IV**

This corporation shall have one director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws, however, there shall never be less than one Director nor more than five.
