ARTICLE 1

NAME OF CORPORATE ENTITY: The name of the corporation shall be American Fund Raising Consultants, Inc.

ARTICLE II

EXISTENCE: The duration of the corporation shall be perpetual; commencement of the corporation's existence shall begin as of the date and time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III

GENERAL PURPOSE: The general purpose for which this corporation has been organized is for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida or the laws of the United States.

ARTICLE IV

ARTICLE VII


