**ARTICLE I - NAME**

The name of this corporation is **ENVIRONMENTAL DESIGN AND DEVELOPMENT CERTIFIED GENERAL CONTRACTORS, INC.** a Florida Corporation.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.
