The name of this corporation is CHATHAM INTERNATIONAL, INC.

ARTICLE II

This corporation shall have perpetual existence.

- B. To do all things and everything necessary, suitable, convenient or proper for the accomplishment of any of the purposes or for the attainment of any or all of the objects herein enumerated, or incidental to the powers herein named, which shall at any time appear conductive or expedient for the protection or benefit of the corporation, either as holders of or as interested in any property otherwise, with all the powers now or hereafter conferred by the laws of the State of Florida upon corporations.
- C. To contract debts and borrow money, sue and sell or pledge bonds, debentures, notes and other evidence of indebtedness and execute such mortgages, transfer of corporate property or other instruments to secure the payment of corporate indebtedness as required.

ARTICLE IV

This corporation is authorized to issue:

10,000,000 shares of preferred stock, par value \$.001. 100,000,000 shares of common stock, par value \$.0001.

ARTICLE V

The stockholders of any class of stock of the Company shall not have preemptive rights to subscribe to further shares of stock.

ARTICLE VI

Cumulative voting is not permitted in any election of directors.

ARTICLE VII
