
Enclosed please find my application for reinstatement for my S-Corporation, The Little Shop of Flowers, Inc.

Please grant my reinstatement and waive my Reinstatement Fee. I have enclosed a check for \$300, which is what the person I spoke with on the phone, Cathy, said I would owe for Report and Supplemental Fees for this year and last year, not including any Reinstatement Fee.

I purchased controlling interest in this corporation at the beginning of 1998. I was not aware of the requirement of filing an Annual Report each year. I apologize for not filing an Annual Report, but I apparently did not receive a 1998 Annual Report Form by mail. Being a new owner, I have been very fastidious about keeping track of mail, especially documents dealing with the State of Florida and the IRS. Not having gotten the form, I didn't know about the requirement. This corporation was subsequently canceled on October 16, 1998, a fact I was not aware of until I made an inquiry about Sales Tax with the Florida Department of Revenue.
