We, the undersigned natural persons of the age of twenty-one or more, acting as Directors and Incorporators under the provisions of the Florida Statutes, Chapter 607, adopt the following Articles of Incorporation:

# ARTICLE I

#### Name

The name of this corporation shall be:

#### ARTICLE II

## Principal Place of Business

The principal place of business is to be located at 6349 82nd Avenue North, Pinellas Park, Florida 33781.

# ARTICLE III

# Term of Existence

The duration of this corporation is to be perpetual.

#### Purpose.

Any action of the shareholders may be taken without a meeting if consent in writing, setting forth the action so taken, shall be signed by all persons who would be entitled to vote upon such
