ARTICLE I - NAME

The name of this corporation is RENEGADE INVESTMENTS OF MARCO ISLAND, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

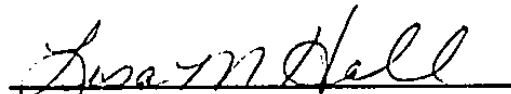

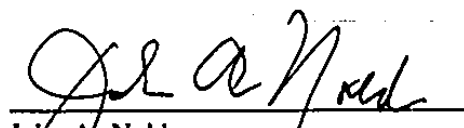
