The undersigned, subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents those Articles for the formation of corporation under the provisions of Chapter 621, Florida Statutes, also known and the Professional Service Corporation Act, and other laws of the State of Fiorida.

# ARTICLE I

# ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:
