The name of the corporation shall be PREFERRED LEGAL UTILIZATION SERVICES, INC. The mailing address for the corporation is 3942 Tamiami Trall North, Sarasota, Florida, 34234.

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually.

#### ARTICLE III - PURPOSE
