**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as an Incorporator of a Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation for said corporation.

**Article I - Name**

The name of this Corporation is High Road Apparel, Inc.

**Article II - Term of Existence**

This Corporation is to have perpetual existence.

**Article III - Purpose**

The purpose of this Corporation is to engage in the transaction of any and all business permitted under the Laws of the United States and of the State of Florida, or other State where the Corporation may desire to operate.

**Article IV - Capital Stock**

The maximum number of shares of stock that this Corporation is authorized to have issued and outstanding at any one time is one thousand (1000) shares of common stock with no par value.

#### **Article V - Preemptive Rights**

Every stockholder of this Corporation, upon the sale for cash of any new stock of the same kind, class or series as that which he already owns, shall have the right to purchase his pro-rata share thereof, as nearly as may be done with the issuance of fractional shares, at the price at which it is offered to others.

#### **Article VI - Address**

The street address of the initial registered office of the Corporation is 3082 O'Brien Drive, Tallahassee, Florida 32308, and the name of the initial registered agent at such address is James T. Doyal. This is also Principal office address.

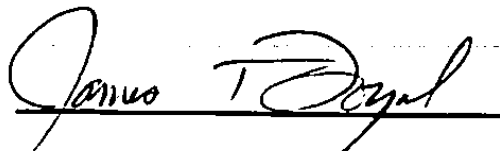
#### **Article VII - Directors**
