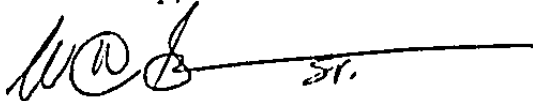

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

I.

The name of the corporation is National Translink Corporation of Jacksonville.

II.

The principal place of business and mailing address of this corporation shall be:

Jacksonville, FL 32216

III.

The corporation shall have authority to issue 10,000 shares of stock.

IV.

Any action required by the Florida Business Corporation Act to be taken at a meeting of the shareholders of the corporation or any action which may be taken at a meeting of the shareholders may be taken without a meeting if written consent, setting forth the action so taken, shall be signed by persons who would be entitled to vote at a meeting those shares having voting power to cast not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting at which all shares entitled to vote were present and voted. Notice shall be given within ten days of the taking of corporate action without a meeting by less than unanimous written consent to those shareholders on the record date whose shares were not represented on the written consent. For purposes of written consent by the shareholders, the record date shall be the date when the consent is first executed and action shall be deemed taken when executed by the last necessary signature. No consent shall be effective as approval of a plan of merger or plan of consolidation unless the requirements for the effectiveness of such consent set forth in the Florida Business Corporation Act have been met.

V.

The initial registered office of the corporation shall be at 2120 Corporate Square Blvd., Suite 18, Jacksonville, FL., Duval County. The registered agent of the corporation shall be William H. Beecher, Sr..
