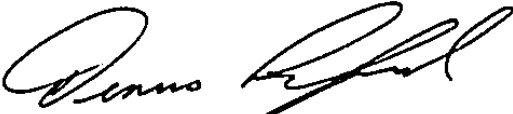

ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- DISTINCTIVE DESIGNS, INC.
and whose principal office location is 1750 CALUMET STREET
CLEARWATER FL 34625

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
CABINET MANUFACTURE AND INSTALLATION and shall include the
transaction of any and all lawful business for which corporations may be
incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock, having
a par value of \$1.00 per share.

The stock as foresaid shall be paid for in lawful money of the United
States, or in property, labor or services at a just valuation to be
fixed by the incorporators, or by the Board of Directors at a meeting

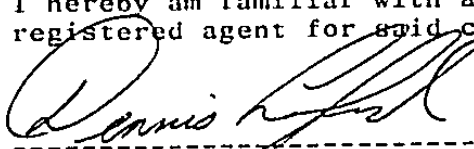
ARTICLE IX - POWERS
