ARTICLE I - NAME

The name of this Corporation is Gifford Mayberry, Inc.

ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

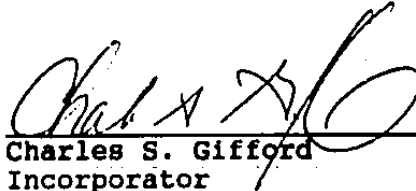
