ARTICLE OF INCORPORATION

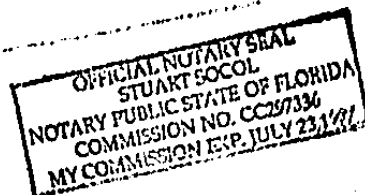
