ARTICLE I. NAME: The name of the corporation is EJ Orr Concrete, Inc.

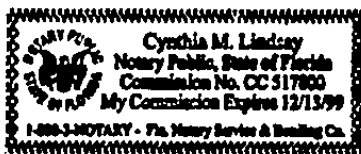


