The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

Article I - Name

The name of this corporation is CLAPBOARD CREEK INCORPORATED.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Shares

The aggregate number of shares which the corporation shall have authority to issue shall be 1,000 of a par value of 10 cents per share.

Article V - Registered Office and Registered Agent

The street address of the initial registered office and principal office of this corporation is 6233 Heckscher Drive, Jacksonville, FL 32226 and the name of the initial registered agent of this corporation at that address is Robert J. Safreed.

Article VI - Initial Board of Directors

The corporation shall have four directors initially. Thereafter, the number of directors may be either increased or decreased

#### **Article X - Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share

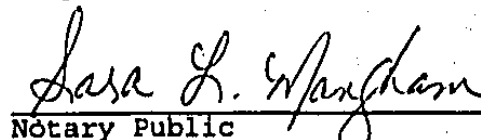
thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
