The undersigned, being of legal age and desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act", executes the following Articles of Incorporation.

ARTICLE 1

Name

The name of the Corporation is YK Chung Enterprises, Inc.

ARTICLE II

Commencement of Corporation Existence

This Corporation shall commence immediately upon the filing of these Articles of Incorporation and shall have perpetual duration unless sooner dissolved according to law.

ARTICLE III

Purpose and General Powers

Initial Registered Office and Agent; Principal Place of Business

The initial registered office of this Corporation shall be located at the City of Orlando County of Orange and State of Florida, and its address there shall be, at present, 256 South Ivey Lane, Orlando, FL, and the initial registered agent of the Corporation at that address shall be Kyung S. Chung. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these

Articles of Incorporation. The principal place of the business and the mailing address of the Corporation shall be the same as the registered office.

ARTICLE VI

Initial Board of Directors
