ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purposes of forming a corporation under the provisions of Chapters 607 and 621, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: JOHN H. BONURA, D.M.D., P.A. The purpose of this professional association is to provide dental services to the general public through its director, JOHN H.
