ARTICLES OF INCORPORATION OF

Dolan & Escalona, P.A.

The undersigned incorporators for the purpose of forming, a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME
