Article 1 - Name
The name of this corporation is Rugged Brands, Inc.

#### Article III - Commencement

This corporation shall commence on the date of the filing of these Articles.

### Article IV - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

#### Article V - Capital Stock


