ARTICLES OF INCORPORATION

of

The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

GARDENING BY CHARLIE & CO., INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to conduct business in lawn maintenance and gardening, and all other lawful business within the State of Florida.

ARTICLE III. CAPITAL STOCK

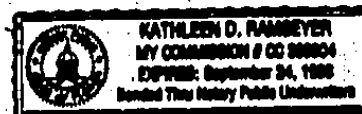
