ARTICLE I - NAME

THE NAME OF THE CORPORATION SHALL BE: **ACR SERVICES, INC.**

ARTICLE II - NATURE OF BUSINESS

THE GENERAL NATURE OF THE BUSINESS TO BE TRANSACTED BY THIS CORPORATION IS AS FOLLOWS:

TO DO ALL THINGS WHICH ARE AUTHORIZED




