The name of this corporation shall be

SOUTHERN TRAX, INC.

ARTICLE 2 - CORPORATE EXISTENCE

This corporation shall have perpetual existence.

ARTICLE 1 - GENERAL MATURE OF BUSINESS

The corporation is formed and shall have as its general purposes all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE 4 - CAPITAL STOCK
