5. **TERM OF EXISTENCE.** This corporation is to exist perpetually.

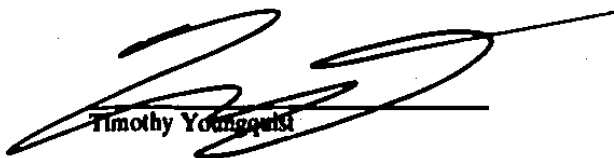

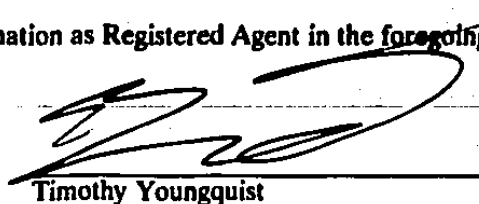
