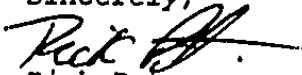

The name and address of the person signing these Articles is Luis M. Barreras whose address is 6312 SW 20th Street, Miramar, FL, 33023.

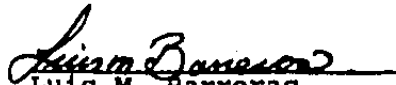
ARTICLE VIII - INDEMNIFICATION

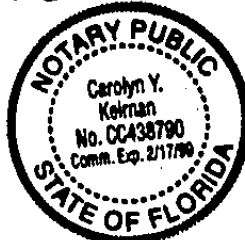
