#### **ARTICLE VIII. INCORPORATOR**

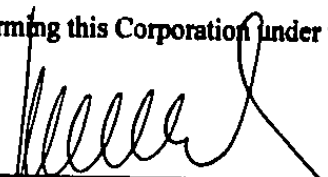
