BY THESE ARTICLES OF INCORPORATION, the Undersigned, acting as Incorporator of a corporation pursuant to 617 Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is INTERNET BUSINESS EXCHANGE INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of this corporation shall be: 8670 Bridle Path Court, Davie, Florida 33328.

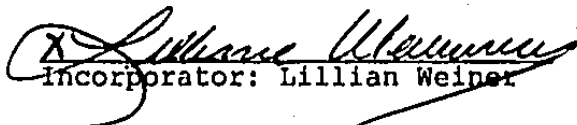

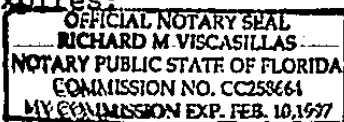
