ARTICLE I-Name

The name of this corporation is **JABAR DIAMOND CORPORATION**.

The Corporation's mailing address and principal place of business is at 7040 West Palmetto Park Road, Building Number 4, Suite 464, Boca Raton, Florida, 33433.

ARTICLE II-Duration

This Corporation shall be perpetual commencing as of 10/21/96.

ARTICLE III-PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business including but not limited to:

- (a) Gemological Appraisals and Gem Testing.
- (b) Wholesale diamonds, colored gemstones, and jewelry.
- (c) Import and export of diamonds, colored gemstones and jewelry and goods and merchandise of any nature whatsoever.

- (k) Buy and sell real and personal property of any nature whatsoever.

- (l) Convey, sell, assign, transfer, lease, mortgage, pledge, exchange or otherwise deal with any property.
- (m) Purchase, pay cash or issue capital stock debentures, bonds, mortgages, or other obligations of the corporation for any acquisition by the corporation and for any other lawful purpose.
- (n) Engage in the acquisition, ownership, sale, distribution and licensing of patents, improvements and franchises, trademarks and trade names, and to operate thereunder.
- (o) Enter into, make and perform contracts of every kind and description with any person, firm or association, corporation and body politic conducive to the attainment of any of the objects or purposes of the corporation.
- (p) Enter into any and all types of agreements relating to financing, factoring, pawn and guarantees and to guarantee or secure in any way, the debts or obligations of any other persons, firms and/or corporation.
