This corporation is to exist perpetually.


ARTICLE VI: SPECIAL PROVISION



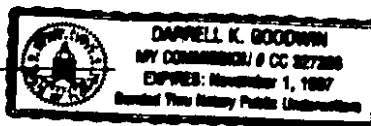
