THE UNDERSIGNED, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. NAME: The name of this corporation is TELECOM 21, INC.

2. ADDRESS: The principal office and initial mailing address of the corporation is: 12240 - 69th Terrace North, Seminole, Florida 33772.

3. DURATION: The period of its duration is perpetual.

4. PURPOSE: The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

- 5. <u>CAPITAL STOCK</u>: The corporation is authorized to issue one hundred (100) shares of common stock at no par value.
- 6. INITIAL REGISTERED OFFICE AND AGENT: The name and address of the initial Registered Agent of this corporation is as follows:

8. BY-LAW AMENDMENT: The power to adopt, alter, amend or repeal the By-Laws of this corporation shall be vested in the Board of Directors and Shareholders.

- 9. INDEMNIFICATION: The corporation may be empowered to indemnify any officer, or any former officer, in the manner set out and provided for in the By-Laws of this corporation, pursuant to the provisions of Section 607.014 of the Florida Statutes, as amended.
- 10. CORPORATE AFFAIRS: The affairs of the corporation shall be managed by its Shareholders.
- 11. AMENDMENT OF ARTICLES: This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the Shareholders is subject to this reservation.
- 12. PRE-EMPTIVE RIGHTS: Each Shareholder of this corporation shall have the first right to purchase shares, and securities convertible into shares, of any class, kind or series of stock in this corporation that may from time to time be issued, whether or not presently authorized, including shares from the Treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of Treasury shares. This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the Shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
 - 13. INFORMAL ACTION OF SHAREHOLDERS: Any action of the Shareholders

may be taken without a meeting if consent in writing setting forth the actions so taken shall be signed by all the Shareholders who would be entitled to vote upon such action at a Shareholders meeting and filed with the Secretary of the corporation as part of the corporate records.
