ARTICLES OF INCORPORATIONOF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME. The Name of the corporation is: A.P.D.P., ENTERPRISES INTERNATIONAL, INC. located at 2025 Lavers CL #D410, Delray Beach, FL 33444.

ARTICLE II. DURATION. The term of existence of the corporation is perpetual.

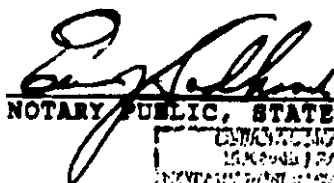

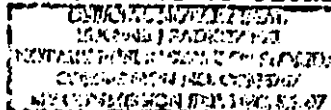
