ARTICLES OF INCORPORATION OF VCP-RERNAN, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is VCP-Kernan, Inc.

ARTICLE II

Principal Office
