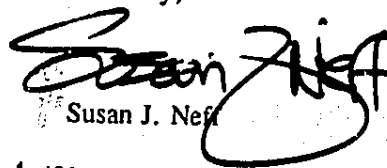

ARTICLE ONE: The name of the corporation is Organized Chaos, Incorporated.

ARTICLE TWO: The period of its duration is perpetual.

ARTICLE THREE: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of no par value.

ARTICLE EIGHT: The Board of Directors is empowered to make, alter, or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.

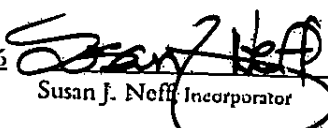
