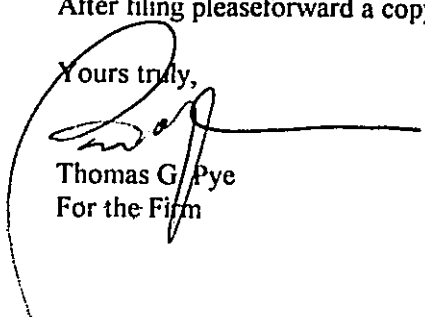

#### ARTICLE 7 - CORPORATE CAPITALIZATION

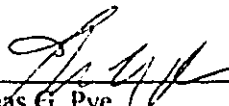
#### ARTICLE 11 - REGISTERED OFFICE AND REGISTERED AGENT

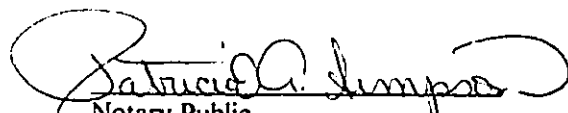

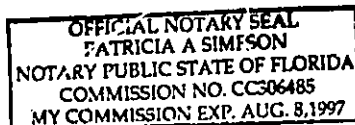
