- 1. The name of the Corporation is currently DATAMARKETS, INC.
- 2. The date of the filing of the Articles of Incorporation was October 9, 1996.
- 3. The Articles of Incorporation are amended as follows:
- a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

"The name of the corporation shall be "COMMERCE SERVICES, INC." (the "Company") and its principal place of business and mailing address shall be 4770 Biscayne Blvd., Suite 880, County of Miami-Dade, State of Florida 33137. The Company shall have the power and authority to establish branch offices at such place or places as may be designated by the officers and directors."
