AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
DATAMARKETS, INC.

The undersigned do hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of DATAMARKETS, INC.

1. The name of the Corporation is currently DATAMARKETS, INC.
2. The date of the filing of the Articles of Incorporation was October 9, 1996.
3. The Articles of Incorporation are amended as follows:
 - a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

"The name of the corporation shall be "COMMERCE SERVICES, INC." (the "Company") and its principal place of business and mailing address shall be 4770 Biscayne Blvd., Suite 880, County of Miami-Dade, State of Florida 33137. The Company shall have the power and authority to establish branch offices at such place or places as may be designated by the officers and directors."
 - b. In all other respects, the Articles of Incorporation shall remain unchanged.
3. This Amendment was adopted by a written statement signed by the sole shareholder and sole director of DATAMARKETS, INC. on November 4 1999, pursuant to Section 607.1006 of the Florida Statutes.
4. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.

the facts herein stated are true, and execute this Amendment to the Articles of Incorporation this

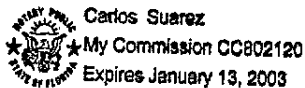
