

Article I - Name

The name of this Corporation is Adnil Corporation.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

Article IV - Capital Stock

This Corporation is authorized to issue 30,000 shares of One Dollar (\$1.00) par value common stock.

Article V - Initial Street Address

The street address of the initial principal office of this corporation is 1419 SE 37th Avenue, Ocala, Florida, 34471, and the name of the initial registered agent of this Corporation at that address is Eugene R. Day.

Article VI - Initial Board Of Directors

This Corporation shall have two (2) directors initially. The number of directors may either be increased or decreased from time to time by the By-Laws, but shall never be less than one. The name and address of the initial directors of this corporation are:

Article VIII - Indemnification

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

Article IX - Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


ARTICLE X - Registered Agent
