Dear Divisions of Corporations:

Enclosed is the 1997 Profit Corporation Annual Report Form along with the \$165.00 filing fee. Although the Annual Report Form is dated subsequent to May 1, 1997, we have not enclosed the late filing penalty fee due to the fact that we experienced a delay in receiving the Annual Report Packet.

Unfortunately, we were unable to determine whether the delay was caused by the Postal Service or our receipt of the Annual Packet at the above mailing address, (812 E. Atlantic Ave., Delray Beach, FL). The mailing address of the business is the same as the physical location of the business. When we incorporated on October 14, 1996, we expected the business to be open in late January or early February. However, due to numerous delays on the part of the landlord, renovations to the place of business are still not complete. Accordingly, we have not been able to start up the business as of the date of this letter.
