ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME.

The name of this corporation is Cardinal Rehab, Inc.

ARTICLE II. CORPORATE DURATION.

The duration of the corporation is perpetual.

ARTICLE III. PURPOSES AND POWERS.

The general purposes for which the corporation is organized are:

To engage in business.

2. To transact any other lawful business for which corporations may be incorporated under Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of director of the corporation, be advantageously carried on in connection with or auxiliary to the forgoing business.

3. To purchase, receive by way of gift, subscribe for, invest in, and in all other ways acquire, import, lease, possess, maintain, handle on consignment, own, hold for investment or otherwise, use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign, and in all other ways dispose of, design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant, and in all other ways (whether like or unlike the forgoing), deal in and with property of every kind and character, real, personal or mixed, tangible or intangible, wherever situated and however held, including but not limited to, money, credits, securities, stocks, bonds, warrants, script, certificates, notes, commercial paper, and other obligations and evidences of interest in or indebtedness of any person, firm corporation, foreign or domestic, or of any government or subdivision or agency thereof, documents of title and accompanying rights and every other kind and character of personal property, real property (improved or unimproved) and the products and avails thereof, and every character of interest therein and appurtances thereto, including but not limited to, mineral, oil, gas, and water rights, all or any part of any going business and its incidents, franchises, subsidiaries, charters, concessions,

grants, rights, powers, or privileged, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing and to exercise in respect thereof all the rights, powers, privileges, and immunities of individual owners or holders thereof.
