NAME

The name of the corporation is CENTENNIAL RACING, INC.



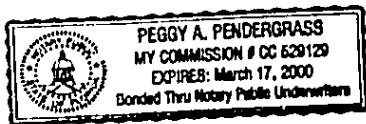
