**ARTICLES OF INCORPORATION

This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation hereinafter mentioned, and to that end, does, by these Articles of Incorporation, set forth the following:

**ARTICLE I**

The name of the corporation is SeaBreeze Charters of Key West, Inc.

**ARTICLE II**

The address of the initial registered offices of the corporation shall be Susan M. Cardenas, P.A., 420 Fleming Street, Key West, Florida 33040, and the name of the initial registered agent for the corporation shall be Susan M. Cardenas, a resident of the State of Florida.

**ARTICLE III**

The mailing address of the corporation is P. O. Box 6362, Key West, Florida 33041, and the principal office of the corporation is 420 Fleming Street, Key West, Florida 33040.

#### **ARTICLE IV**

The nature of the business and the objects and purpose or purposes to be transacted, promoted, or carried on by the corporation are to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida. In addition, the corporation shall have the power to carry on business of any character that is not prohibited by law or required to be stated in the articles.

#### **ARTICLE V**

The total number of shares which this corporation is authorized to issue is 5000 shares of common stock with one dollar (\$1.00) par value for each share. Shareholders of the corporation shall have a preemptive right to purchase treasury or non issued capital stock of the corporation and to vote their shares on a cumulative basis for the election of the Board of Directors.


