of

ARTICLE I

The name of this corporation shall be **P Z ON-LINE, INCORPORATED.**

ARTICLE II

The principal office and mailing address of this corporation shall be:

ARTICLE III

This corporation is formed for the purpose of conducting any business or
business transaction lawfully permitted by the Florida Business Corporation Act.

ARTICLE IV

The aggregate number of shares of capital stock authorized to be issued by
this corporation shall be 1000 shares of common stock, with a par value of \$5.00 per
share, the consideration for which may be paid by money, property, or services as

ARTICLE V

This corporation shall have perpetual existence.

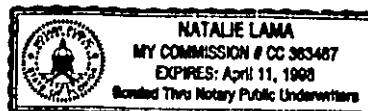

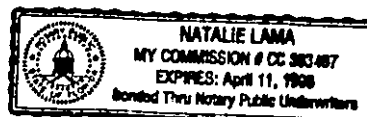
