## ARTICLES OF INCORPORATION of

#### KING AUTO FINANCING, INC

The undersigned subscribers to these Articles of Incorporation, we each a natural person competent to contract hereby associated themselves together to form a corporation under the laws of the State of Florida, United States of America.

ARTICLE I. The name of the corporation shall be:

#### KING AUTO FINANCING, INC

ARTICLE II. The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things permitted or provided by Statutes and those hereinafter set out as fully and to the same extent as natural persons might or could do:

- a) To improve, buy, sell, exchange, martgage, rent, lease, Invest in, build, erect, equip, maintain, deal in and with, dispose of, manage and operate real property, both improved and unimproved, and personal property of whatoever nature or kind, or awner, agent, factor, or broker; to build, construct and after houses, buildings and structures of whatsoever nature or kind, and to develop real property generally, to loon maney upon real and personal property and to take martigages and bonds, and assignments of martigages and bonds upon real and personal property of whatsoever nature or kind; and to borrow money thereon by martgage or otherwise; to buy, sell, and deal in bonds and loans secured by martgages or other liens on real property or personal property of all kinds and description;
- To purchase, manufacture, acquire, hold, own, mortgage, hypothecale, pledge, lease, sell, assign, transfer, invest in, trade in, deal in, borrow and lend maney upon goods, wares, merchandise and real and personal property of every kind and description;
- c) To act as agent, broker or attorney in fact for any persons, firms or corporations in buying, selling and dealing in real or personal property of whatsoever nature or kind, and any and every estate and interest therein, and choses in action secured thereby, judgments resulting therefrom, and other personal property collateral thereio, in making and obtaining loans upon such property, in supervising, managing and protecting such property and loans and all interest in and claims offecting the same, in effecting insurance against fire and all other risks thereon, and in managing and conducting any legal actions, praceedings and business relating to any of the purposes herein mentioned or referred to, to register martigues and deeds of trust of real property or chattels real and all other securities collateral thereto, to investigate and report upon the credit and financial solvency and sufficiency of bottowers and success upon such securities; and to transact all or any other business which may be necessary or incidental er proper to the exercise of any or all of the purposes of the corporation.
- d) To subscribe for, purchase, invest in, hold, own, assign, pledge, and atherwise dispose of shores of capital stock, bonds, maripages, debeniures, notes and other securilies, obligations, contracts and evidences of indebtedness of any persons, firms, associations, or other corporations, whether domestic or foreign, and to exercise in respect of any such stores of stocks, bonds, and other securilies, any and all rights, powers and privileges of individual ownership, including the right to vote thereon, to issue bonds and other obligations, and to secure the same by pledging or marigaging the whole or any part of the property of the company, and to sell such bonds and other obligations for proper carporate purposes, and to do any and all acts and things tending to increase the value of the property at any time held by the company;
- e) To acquire, hold, undertake, and fully exploit the goodwill, property, rights, franchises, and assets of every kind, and the liabilities of any person, firm, association or corporation, either wholly or partly, and to pay for the same in cash, stocks, or bonds of the company or otherwise;
- f) To borrow money and contract debts when necessary in the purchase or acquisition of real, personal and intengible property, business rights or franchises, or for additional working capital, or any other object in or about its business or affairs and without limit as to amount, to incur debt and to raise, borrow and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust or otherwise;
- g) In any manner to acquire, enjay, utilize and to dispose of patents, copyrights, and trademarks, and any license or other rights or interest therein and thereunder;
- h) To conduct business and operations, and to have one or more offices and hold, purchase, mortgage, lease, dispose of, deal in, and convey real and personal property without restrictions in this State and in any other of the several States, territories, possessions, and dependencies of the United States, the District of Calumbia, and in any and old larging countries;
- 1) To purchase or otherwise acquire, become interested in, deal in and with, invest in, hold, pledge, seil, martigage, lend money an, exchange or otherwise dispose of, or turn to account or realize upon as awner, agent, broker, or factor, all forms of securities, including stacks, bonds, debentures, martigages, nates, evidences of indebtedness, leases, options, certificates of interest, participation certificates, voltage trust cartificates evidencing shares of or interest in routs, rouman law trusts, trusts and trust estates or ausociations, certificates of trust or beneficial interest in trusts, martigages, contracts and other instruments, securities and rights, to investigate and report with respect to, and to undertake, corry on, old, autit or participate in the organization, illudation or reorganization of financial, commercial, mercanitie, manufacturing, industrial or other business concerns, firms, associations and corporations; to institute, participate in, or promote commercial, mercanitie, financial and industrial enterprises and operations;

ARTICLE III. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

10,000 SHARES AT A PAR VALUE OF \$1.00 EACH.

All of said stock shall be payable in cash, property, real or personnel, labor or services in lieu of cash at a just and fair valuation to be fixed by the Board of Directors of this corporation.

ARTICLE IV. The amount of capital with which this corporation shall commence business shall be not less than One Thousand Dollars which sum has been subscribed.

ARTICLE V. This corporation shall exist perpetually unless sooner disolved according to law.

ARTICLE VI. The initial street address of the registered office of this corporation in the State of Florida is:

ARTICLE VII. This corporation shall have three directors initially. The number of directors may be increased or diminished from time to time, by by-laws adopted by stockholders, but never less than one.
