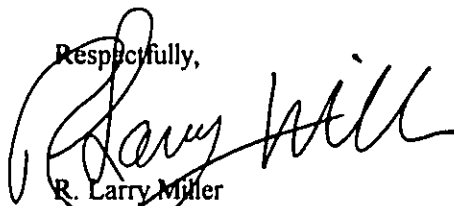

I, the undersigned, hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation for profit under the laws of the State of Florida and do hereby further certify that I have become such corporation under and pursuant to the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is:

Tergo Communications, Inc.

**ARTICLE II**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The corporation shall have the power, in addition to and not in limitation of other powers, to adopt a plan or plans pursuant to Section 1244 of the Internal Revenue code and issue stock pursuant thereto.

**ARTICLE III**

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time is:

Six thousand (6,000) shares of the par value of one dollar (\$1.00) each, amounting to six thousand dollars (\$6,000).

**ARTICLE IV**

The amount of capital with which this corporation shall and does hereby begin business, shall be and is the sum of \$1,000.

**ARTICLE V**

The corporation shall have perpetual existence.

#### ARTICLE VI

The initial address of the principal office of this corporation shall be and is: 703 116<sup>th</sup> Avenue West, Tampa, Florida 33612-5611.

#### ARTICLE VII

The number of the Directors of this corporation shall be 2. That number may be increased from time to time by the by-laws adopted by the stockholders.

#### ARTICLE VIII

The name and address of the first Board of Directors, who subject to the provisions of this Certificate of Incorporation, by-laws of this corporation and the laws of the State of Florida, shall hold office for the first year of the corporation's existence or until their successors are elected and qualified.

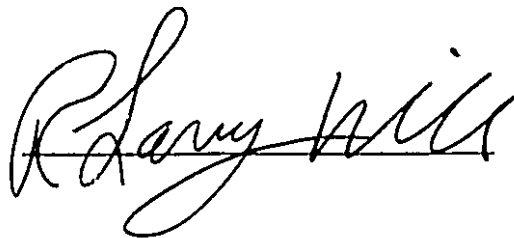

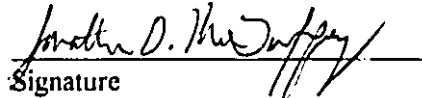
