Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **Jolly Roger Grill, Inc.**, and the initial corporate address is 23402 Panama City Beach Parkway, Panama City Beach, Florida 32413.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having a par value of \$5.00 per share.

Article IV. Term of Existence

Article X. Preemptive Rights


