#### ARTICLES OF INCORPORATION

OF

CYPRESS LAKES DEVELOPMENT, INC.



The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

### ARTICLE I

#### Name

Section 1.1. Name. The name of the corporation is Cypress Lakes Development, Inc.

#### ARTICLE II

#### Duration

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually.
