ARTICLES OF INCORPORATION

OF

KEY ACCOUNTING SERVICES, INC.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

1. **NAME.** The name of the corporation is KEY ACCOUNTING SERVICES, INC.

2. **PRINCIPAL OFFICE/MAILING ADDRESS.** The principal office and mailing address of the corporation is 1232 Southeast 12th Avenue, Deerfield Beach, Florida 33441.

3. **SHARES.** The number of shares the corporation is authorized to issue is one thousand (1000) shares. The par value for the authorized shares is One Dollar (\$1.00).
