The undersigned incorporator hereby forms a corporation under Chapter 607, Florida Statutes, as follows:

Article I-Name

The name of the corporation shall be Mauro LaGrasta Custom Builders, Inc., and the principal office and the mailing address of the corporation shall be 695 106th Avenue North, Naples, FL 34108.

Article II-Nature of Business

The corporation is authorized to conduct any activities as are permitted under applicable Florida Statutes.

Article III-Capital Stock
