The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation is **SUNRISE OFFICE MACHINES OF SOUTH FLORIDA, INC.**

**ARTICLE II - TERM**

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is when the Articles are received in the office of the Secretary of State.

**ARTICLE III - PURPOSE**

The general purposes for which the corporation is organized are:

1. Office machine sales;
2. To transact any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares. Such shares

shall be of a single class and shall have a par value of One (\$1.00) Dollar per share.

#### **ARTICLE V - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### **ARTICLE VI - ADDRESS**

The street address of the initial registered office of the corporation is 312 S.E. 17th Street, Second Floor, Ft. Lauderdale, Florida 33316 and the name of the initial registered agent at such address is Damaso W. Saavedra, Esq. #### **ARTICLE VII - DIRECTORS**

The number of directors constituting the initial Board of Directors of the corporation is two (2). The number of directors may be either increased or decreased from time to time by the Bylaws but shall never be less than two (2). 
## ARTICLE IX - BYLAWS


