ARTICLES OF INCORPORATION OF

THE UNDERSIGNED acting as the sole incorporator of a corporation to be formed under the Florida General Corporation Act, adopts the following Articles of Incorporation:

PIRST: The name of the Corporation is <u>Speedy Air Conditioning</u>, Inc.

SECOND: The purpose or purposes for which the Corporation is organized are:

To engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

THIRD: The aggregate number of shares which the Corporation shall have authority to issue is one thousand (1,000) shares of common stock, and the par value of each such share is one dollar, (\$1.00), amounting to One Thousand Dollars, (\$1,000.00).

FOURTH: The street address of the initial registered office of the Corporation is <u>1100 5th Ave. S. #211 Naples, FL 34102</u>, and the name of its initial registered agent at such address is <u>John S.Winnie.</u>

FIFTH: The name and address of the sole incorporator is <u>John</u> <u>S. Winnie, 1100 Fifth Avenue South, Suite 211, Naples, FL 34102</u>. The sole incorporator shall have no interest in the corporation other than as organizational attorney and shall serve in such capacity until the adoption of resolutions organizing the Corporation.

SIXTH: Upon the offering or sale by the Corporation for cash of its shares of capital stock, including without limitation, warrants, subscription rights or options to acquire shares (collectively "convertible securities"), whether out of the number of shares of capital stock now authorized or out of shares of capital stock of the corporation acquired by it after issuance, each shareholder shall have the preemptive right to the fullest extent provided by law and the provisions of these Articles of Incorporation to purchase such shares or convertible securities in proportion to the number of shares held by such shareholder, within the time and on the terms fixed by the Board of Directors of the Corporation.

SEVENTH: The principal office of the corporation shall be located at <u>8410 Mallow Lane Naples, Florida 34113 and its mailing</u> <u>address is the same.</u>
